Its objectives are to promote the completion of the internal market for gas and stimulate cross-border trade, ensure the efficient management and coordinated operation of the European gas network and facilitate the European network's sound technical evolution.

ENTSOLOG is comprised of seconded staff from its members as well as directly hired staff and therefore the organisation is constantly under dynamic change and ready to offer new opportunities. The ENTSOG staff currently consists of 40+ people of 18 different nationalities, a good gender balance and representing 15 companies, which provides a unique and challenging international working environment.

# CANDIDATE REQUIREMENTS

The Candidate will be **based in Brussels** and should be ready to start work **as soon as possible**, at the latest during Q2/2021. The frequency and pattern of presence in Brussels can be discussed during the selection process.

Appointees from ENTSOG Members will be seconded based on a contract between ENTSOG and the seconding TSO, usually for a period of typically 3 years. Candidates seconded from TSOs are preferred.

## SOME OF THE KEY RESPONSIBILITIES OF THIS ADVISER ROLE INCLUDE:

- ▲ Supporting the members for the implementation of the data exchange rules,
- ▲ managing ENTSOG's internal expert groups,
- ▲ cooperating with external experts and IT Security organisations such as ENISA and CERT-EU,
- ▲ developing and maintaining Business Requirement Specifications in cooperation with EASEE gas,
- ▲ developing positions in relation to cybersecurity, and
- ▲ investigating digital solutions for the future integrated energy grids.

## CANDIDATES SHOULD HAVE:

- ▲ technical background, preferable degree in IT, engineering or equivalent
- ▲ experience with data exchange technologies for the TSO communication with counterparties and data publication including protocols, formats, standards etc.
- ▲ knowledge of cybersecurity requirements of professional entities
- ▲ ideas and ambitions to work on digital solutions, e. g. more dynamic data provisions for the gas quality of renewable gases
- ▲ general knowledge of the European gas market framework
- ▲ specific knowledge of the Network Code for Interoperability and Data Exchange
